Note: for transfers from outside Europe, the OUR option must be selected. With this option the sender bears the costs for the transfer himself.

There will be no refund of the accreditation fees.

- 3) Upon receipt of the complete accreditation application and payment of the accreditation fee, the review process will be initiated by ISAAT Board representatives. The representatives will review the application for formal completeness.
- 4) Upon completion of the formal review, the application is forwarded to two independent members of the ISAAT Accreditation Board.
- 5) The processing time varies and can take from 3 to a maximum of 6 months.
- 6) If the board chairpersons or the independent accreditation board find any ambiguities or need further information, they will contact you.
- 7) The Accreditation Board will forward a recommendation for acceptance, acceptance under certain conditions or rejection to the ISAAT Board, which will make a decision accordingly.
- 8) This recognition is valid for 5 years. After this period, re-accreditation will be required.
- 9) If the ISAAT Board approves the accreditation application, the institution becomes a full member of ISAAT at the same time and must then transfer the applicable membership fees to the above account.
- 10) The recommendation of the ISAAT Accreditation Board or the decision of the ISAAT Board is final and cannot be legally challenged. However, a new application may be submitted in accordance with the accreditation guidelines.



- 11) Changes in curriculum or faculty must be reported to ISAAT if they constitute permanent changes in the curriculum or if temporary changes in subjects or faculty affect more than 15% of the classes.
  
- 12) Full members of ISAAT may use the following text in their published materials (e.g., Web sites, course brochures) and on their certificates of completion: "The training has been accredited by the International Society for Animal Assisted Therapy. It is conducted according to the currently valid ISAAT standards."
